Deadline: March 7, 2025

In fairness to all applicants, **applications must be submitted or postmarked on or before March 7, 2025**. The Allen Law Firm will award fifteen **\$2,000 scholarships** this year to students throughout Virginia, according to the following criteria:

1. The applicant must be a senior in a Virginia high school whose plans include advanced education through college, nursing, business, trade, technical training or similar program. Future plans are not required to be in Virginia.
2. All sections of the application must be **completed in full, with all materials submitted together**; incomplete applications will not be eligible for consideration.
3. Application and all supporting materials must be submitted or postmarked by **March 7, 2025**. Submission instructions can be found on the last page of this application.
